<p>½ Day in Reflection Room</p> <p>11am – 3.30pm</p> <p>Tracker Tariff – 5 points</p>	<ul style="list-style-type: none"> • Missing/failing detention • Failing Matrix • Walking away from SLT 	<ul style="list-style-type: none"> • Restorative conversations with learning manager before 10.30am. Student will be issued with a red sticker to inform of Reflection time. • Student to attend first break – using red sticker in planner as passport. • Student to meet allocated staff at set point at the end of break to be escorted to Reflection. This is the student’s responsibility. Failure to attend would result in collection and time in Reflection (until 2.30pm) PLUS a full day in Reflection the following day. The Principal may decide to refer for Reflection in another academy for repeat occurrence.
<p>C5 Full day</p> <p>Tracker Tariff – 5 Points</p>	<ul style="list-style-type: none"> • Failure to complete ½ day effectively • Smoking on academy site 	
<p>Reflection time in an alternative Academy – Alternative to FTE</p> <p>Tracker Tariff – 5 Points</p>	<ul style="list-style-type: none"> • Swearing at a member of staff • Violence or threatening behaviour towards others • Breach of health and safety • Failure to comply (inc. handing over a mobile phone) • Failure to complete RR (after two days) 	<p>Please note, this sanction is at the Principal’s discretion and may be a FTE if deemed more serious.</p> <ul style="list-style-type: none"> • Reflection time in an alternate academy is to be used for instances where an FTE would have previously been used. • Immediately following the incident, the student should not be in general circulation within the academy. They should be as appropriate: Bridge, PLC , Reflection Room etc prior to their day in Reflection at an alternative academy. • If the student fails to attend the alternative placement, they should be marked as an unauthorised absence and usual attendance procedures will apply. Safe and well- being checks should be applied. • If a student fails Reflection Room due to non- compliance an FTE should apply. The Consequence day should then be repeated and will not be cancelled.

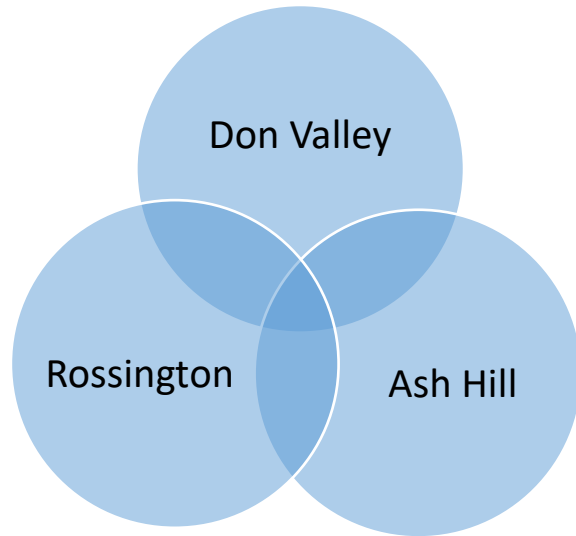

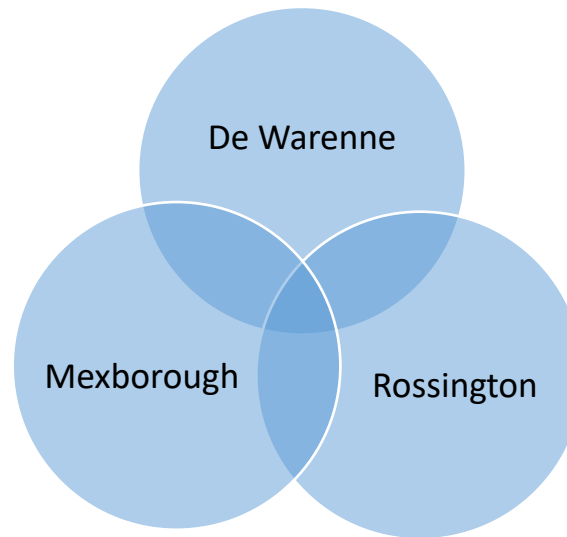
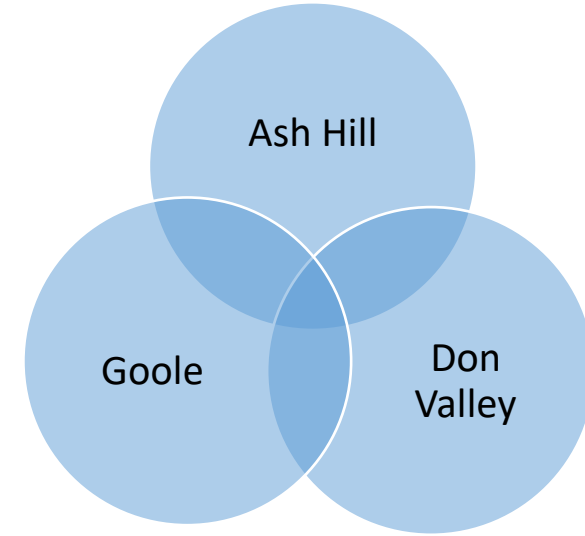
